Eligibility

1. The competition is open to all members of PBAL whose dues were paid by May 1, 2024.
2. *Pine Bluff Art League* and the *Arts and Science Center* reserve the right to refuse any work.
3. Two-dimensional FINE ART media will be accepted. No crafts or sculpture will be accepted. Digitally mastered artwork must be labeled as such, not labeled as mixed media.
4. Artwork must have been created within the last five years.
5. Artwork that has been accepted into a previous PBAL Annual Exhibition is NOT eligible.
6. All artwork must be the artist's ORIGINAL composition. Artwork cannot be copied from another person's composition or photograph. Work copied from another person's artwork or composition is not considered 'original' artwork. No prints that are not original. Three-dimensional work will not be accepted.
7. Entries must be suitably framed (unless a 2" or more wrap-around canvas with painted, finished edges) and ready to hang with wire or D-rings (no saw tooth hangers). Framed works must be matted with white or off-white mats (if matted). There should be no visible nails or tape. There is no minimum or maximum size. Black frames are strongly suggested. No plastic frames.
8. ASC does not sell PBAL artwork. As a courtesy, ASC may have price lists on premises, however, all sales are directly between the artist and buyer. Packaging and shipping artwork is at the expense of the artist or buyer, not ASC.

Entry Fees

Entry fees are non-refundable and must accompany the entry forms and artwork. A \$20 non-refundable fee covers the 1st entry; \$10 fee must be paid for each additional entry. No limit to the number of entries. Checks must be payable to Pine Bluff Art League.

Labels

Attach the entry form label to the upper right corner on the reverse of the artwork. Fill in the blanks for Artists Name, Title, Medium (watercolor, oil, pastel, photography, etc.) and Sale Price/Insurance Value. If the art is not for sale, write NFS, **BUT** still list the insurance value.

Sale of Work

There is no commission on sales to either PBAL or ASC. By providing a 'sale' price, you agree that ASC may share your contact information with a potential buyer. All accepted works must remain on display the entire duration of the show, even if purchased.

Awards

Best in Show: \$250; First Place: \$200; Second Place: \$150; Third Place: \$100; Two Honorable Mentions: \$25

Liability

All reasonable care will be given to the artwork submitted, but entries are submitted at the risk of the artist. PBAL and ASC will not assume any liability for damage or deterioration before, during or after exhibition, nor will PBAL or ASC be liable for loss or damage during transit.

Photography/Reproduction

ASC may photograph the artworks from the exhibition and use images for media, marketing, and educational purposes.
